REGULATION SUBSIDY FOR DENTAL EXAMINATIONS OR TEETH CLEANING

The Management Committee of the F.I.M.I.- E.B.A.R. of Rome and its Province resolves, on an annual basis, to allocate a variable amount for the payment of a subsidy for dental examinations or teeth cleaning, subject to availability of funds.

A total sum of € 10,000.00 (Euro Ten Thousand/00) has been allocated for the current year, subject to availability of funds.

AMOUNTS DISBURSED:

Contribution of € 100.00 (Euro One Hundred/00) -one-time payment per year. VAT will not be refunded under any circumstances.

BENEFICIARIES:

- Permanent agricultural workers (OTI) of Rome and its Province, employees of farms up to date with the payment of F.I.M.I.- E.B.A.R. of Rome and its Province contributions;
- Temporary agricultural labourers (OTD) of Rome and its Province, employed by agricultural holdings up to date with the payment of F.I.M.I. - E.B.A.R. of Rome and its Province contributions, registered in the registry lists in the two-year period preceding the application for at least 51 days;
- Owners of farms operating in the area of Rome and its Province, who are up to date with the payment of F.I.M.I. E.B.A.R. contributions.
- Applicants must not be beneficiaries of other grants for the same purpose and year;

ALLOCATION CRITERIA:

- All benefits and subsidies will only be granted to company owners, and their employees, up to date with their contribution to the FIMI - EBAR of Rome and its Province.
 VAT will not be refunded under any circumstances.
- Contributions will be established year by year by the Management Committee of the F.I.M.I.-E.B.A.R. of Rome and its Province, taking into account the Fund's financial resources;
- If the number of applications submitted by the deadline exceeds the amount approved annually (Euro Ten Thousand/00 €10,000.00), the Management Committee of F.I.M.I.-E.B.A.R. of Rome and its Province, at its sole discretion, will draw up a ranking list based on the following criteria:
 - 1. Family income of everyone in the household (ISEE certification);
 - 2. Family load as per tax certification
 - 3. Date of arrival of the application.

REQUIRED DOCUMENTATION:

Agricultural workers or farm owners wishing to apply for the subsidy for a dental examination or teeth cleaning must submit:

- 1) Application form, using the template provided, downloadable at www.fimiroma.it which must be filled in completely;
- 2) Certificate of family status on plain paper;
- 3) Copy of invoice or receipt for dental examination or teeth cleaning;
- 4) Certificate of registration in the population register or declaration by the employer or copy of the quarterly INPS reports showing the existence of the employment relationship;
- 5) Copy of previous year's income certification (signed CU or mod. 730 or mod. UNICO, INCOME FORM) of ALL THE MEMBERS OF THE FAMILY STATUS or, in the absence of income, the substitute declaration for affidavit certifying the absence of income;
- 6) Applicant's identity document.

DEADLINES FOR ACCEPTING APPLICATIONS:

- Applications, accompanied by all documentation, must reach the F.I.M.I.- E.B.A.R. of Rome and its Province no later than <u>31 DECEMBER</u> of the current year.
- Applications will be examined by the Management Committee and will be granted at its sole discretion.
- Applications that are incomplete, lacking in documentation or received after the deadline will not be considered
