F.I.M.I. – E.B.A.R. OF ROME AND ITS PROVINCE

RULES FOR APPLYING FOR DISABLED/INCAPACITATED FAMILY MEMBERS ALLOWANCE

The Management Committee of the F.I.M.I.- E.B.A.R. of Rome and its Province resolves, on an annual basis, taking into account the financial available funds, to allocate a variable amount for the payment of an allowance for disabled or incapacitated family members, in accordance with the provisions of law 104/92 art. 3 par. 3, subject to availability of funds.

For the current year, a total sum of € 10,000.00 (Euro Ten Thousand/00) has been allocated, subject to availability of funds, according to the established deadline.

Law 104/92 Art. 3. Beneficiaries

- 1. A disabled person is one who has a physical, psychic or sensory incapacity, whether stabilised or progressive, which causes difficulties in learning, relationships or work supplement and which leads to a process of social disadvantage or marginalisation.
- 2. The disabled person is entitled to the benefits established in his or her favour according to the nature and extent of the disability, the overall individual residual capacity and the effectiveness of rehabilitation therapies.
- 3. If the disability, whether single or multiple, has reduced age-related personal autonomy in such a way as to require permanent, continuous and comprehensive assistance in the individual sphere or in the sphere of relationships, the situation takes on the connotation of seriousness. Situations recognised as serious determine priorities in public service programmes and interventions.
- 4. This law also applies to foreigners and stateless persons, resident, domiciled or having a permanent residence in the national territory. The relevant benefits are paid within the limits and under the conditions provided for by current legislation or international agreements.

AMOUNTS DISBURSED:

➤ € 800.00 (Euro 800/00) annually

The amounts indicated may be varied each year by resolution of the Management Committee of FIMI - E.B.A.R. of Rome and its Province and are intended until the funds are exhausted.

BENEFICIARIES:

- Permanent agricultural workers Rome and its Province (OTI and OTD), whose employers are up to date with the payment of F.I.M.I. E.B.A.R. contributions;
- Temporary agricultural workers Rome and its Province (OTD), registered for at least 51 working days in the year preceding the year of application, whose employers are in order with the payment of F.I.M.I. -E.B.A.R. contributions;
- Owners of farms in Rome and its Province who are up to date with the payment of F.I.M.I. E.B.A.R. contributions.

REQUIREMENTS:

- 1. Applicants must <u>not</u> be beneficiaries of other grants for the same purpose and year;
- 2. The applicant must be an employee or owner of a farm up to date with the payment of F.I.M.I. E.B.A.R. contributions in Rome and its Province.

F.I.M.I. – E.B.A.R. OF ROME AND ITS PROVINCE

RULES FOR APPLYING FOR DISABLED/INCAPACITATED FAMILY MEMBERS ALLOWANCE

ALLOCATION CRITERIA:

- All benefits and subsidies will only be granted to companies, and their employees, up to date with their contributions to the FIMI EBAR of Rome and its Province.
- Contributions will be established year by year by the Management Committee of the F.I.M.I.- E.B.A.R. of Rome and its Province, taking into account available funds;
- The subsidy will be reserved for farm owners, OTI and OTD farm workers registered for at least 51 working days in the year preceding the year of application;
- If the number of applications submitted by the deadline exceeds the amount approved annually (Euro Ten Thousand/00 €10,000.00), the Management Committee of F.I.M.I.- E.B.A.R. of Rome and its Province, at its sole discretion, will draw up a ranking list based on the following criteria:
 - 1. Family income of everyone in the household (ISEE certification);
 - 2. Family load as per tax certification
 - 3. Percentage of disability recognised by INPS/INAIL
 - 4. Date of arrival of the application.

REQUIRED DOCUMENTATION:

Agricultural workers or farm owners wishing to apply for the subsidy must submit:

- 1) Application for a subsidy, using the form provided, which can be downloaded from the website and which must be filled in completely (front/back);
- 2) Family status certificate on plain paper issued by the commune of residence;
- 3) Certificate from the competent Commission (INPS/INAIL or other) with degree of invalidity/inability;
- 4) Certificate of registration in the population register or declaration by the employer or copy of the quarterly INPS reports showing the existence of the employment relationship;
- 5) Copy of previous year's income certification (signed CU or mod. 730 or mod. UNICO, INCOME FORM) of ALL THE MEMBERS OF THE FAMILY STATUS or, in the absence of income, the substitute declaration for affidavit certifying the absence of income;
- 6) Copy of identity document

DEADLINES FOR ACCEPTING APPLICATIONS:

- Applications, accompanied by all documentation, must reach the F.I.M.I.- E.B.A.R. of Rome and its Province NO LATER THAN 31 DECEMBER of the current year.
- Applications will be examined by the Management Committee and will be granted at its sole discretion.
- Applications that are incomplete, lacking in documentation or received after the deadline will not be considered
