

# F.I.M.I. – E.B.A.R. OF ROME AND ITS PROVINCE

## RULES OF PARTICIPATION AND ALLOCATION OF SCHOLARSHIPS:

The Management Committee of the F.I.M.I.- E.B.A.R. of Rome and its Province resolves, on an annual basis, the allocation of a variable amount for the disbursement of merit scholarships reserved for the children of agricultural workers and the children of employers, operating in the area of Rome and its Province.

**A total sum of € 20,000.00 (Euro Ten Thousand/00) has been allocated for scholarships for the current year, subject to availability of funds.**

### AMOUNTS DISBURSED:

➤ Secondary school (Key Stage 3)	€ 500.00 (Euro Five Hundred/00)
➤ Secondary school (From Year 9 to Year 13)	€ 600.00 (€ Six Hundred/00)
➤ Secondary school AGRICULTURAL SPECIALIST	€ 1,000.00 (Euro One Thousand/00)
➤ Bachelor's degree (three-year degree or master's degree)	€ 900.00 (Euro Nine Hundred/00)
➤ AGRICULTURAL degree course	€ 1,500.00 (Euro One Thousand Five Hundred/00)

### BENEFICIARIES:

- All students, children of permanent agricultural workers (OTI) of Rome and its Province, employees of farms up to date with the payment of F.I.M.I.- E.B.A.R. of Rome and its Province contributions;  
All students, children of temporary agricultural workers (OTD) in Rome and its Province, employed by farms up to date with the payment of F.I.M.I. - E.B.A.R. contributions in Rome and its Province, registered in the registry lists in the two-year period preceding the application for at least 51 days;
- All students, children of owners of farms operating in the area of Rome and its Province, who are up to date with the payment of F.I.M.I. - E.B.A.R. contributions

### REQUIREMENTS:

1. Applicants must not be beneficiaries of other scholarships for the same year;
2. At least one of the candidate's parents must be an employee of a company up to date with the payment of F.I.M.I.- E.B.A.R. of Rome and its Province contributions, or at least one parent must be an owner of a company up to date with the payment of F.I.M.I.- E.B.A.R. of Rome and its Province contributions.
3. Applicants must have been promoted to the next higher class, or be up to date with their university examinations, or have obtained, in the current school year, a licence or diploma or degree of:
  - ✓ Secondary school (Key Stage 3)
  - ✓ Secondary school (From Year 9 to Year 13)
  - ✓ Secondary school AGRICULTURAL SPECIALIST
  - ✓ Degree (Bachelor's or Master's)
  - ✓ AGRICULTURAL Degree

### ALLOCATION CRITERIA:

- the scholarships will be allocated in a fixed number, which will be established from year to year by the F.I.M.I.- E.B.A.R. of Rome and its Province Management Committee, taking into account the Fund's financial resources;
- If the number of applications submitted by the deadline exceed the number fixed annually, the Management Committee of the F.I.M.I.- E.B.A.R. of Rome and its Province, at its sole discretion, will draw up a ranking list based on the following criteria:
  1. family income of everyone in the family status
  2. school score;

3. family load as per tax certification.
4. Application submission date: tender opening 01/09 current year - closing 31/12 current year

### REQUIRED DOCUMENTATION:

Workers or company owners wishing to compete for scholarships for their children must submit:

- 1) Application form to participate, using the template provided, which must be filled in completely (front/back);
- 2) Certificate of family status on plain paper;
- 3) A document showing the score obtained in the current school year;
- 4) Certificate of enrolment or attendance at Secondary school (Key Stage 3) or Secondary school (From Year 9 to Year 13) courses or degree for the current school year.
- 5) Certificate of registration in the population register or declaration by the employer or copy of the quarterly INPS reports showing the existence of the employment relationship;
- 6) Copy of previous year's income certification (signed CU or mod. 730 or mod. UNICO, INCOME FORM) of ALL THE MEMBERS OF THE FAMILY STATUS or, in the absence of income, the substitute declaration for affidavit certifying the absence of income;
- 7) In case of an orphan of a worker, in addition to the above documents, the death certificate of the deceased worker will also be required and the application may be signed by the parent or by the applicant himself if he is of age.

### DEADLINES FOR ACCEPTING APPLICATIONS:

- Applications, accompanied by all documentation, must reach the F.I.M.I.- E.B.A.R. of Rome and its Province no later than **31 DECEMBER** of the current year.
- Applications will be examined by the Management Committee and scholarships will be granted at its sole discretion.
- Applications that are incomplete, lacking in documentation or received after the deadline will not be considered
