

# F.I.M.I. – E.B.A.R. OF ROME AND ITS PROVINCE

## SCHOOL BOOK PURCHASE SUBSIDY REGULATION

The Management Committee of the F.I.M.I.- E.B.A.R. of Rome and its Province resolves, on an annual basis, to allocate a variable subsidy for the purchase of school books.

A total sum of € 10,000.00 (Euro Ten Thousand/00) has been allocated for the current year, subject to availability of funds.

### AMOUNTS DISBURSED:

The recognised subsidy is € 150.00 (Euro One Hundred and Fifty/00) which may be claimed by one parent only once per year. VAT will not be refunded under any circumstances.

### BENEFICIARIES:

- Permanent agricultural workers Rome and its Province (OTI and OTD), whose employers are up to date with the payment of F.I.M.I. - E.B.A.R. contributions;  
Temporary agricultural workers Rome and its Province (OTD), registered for at least 51 working days in the year preceding the year of application, whose employers are in order with the payment of F.I.M.I. - E.B.A.R. contributions;
- Owners of farms in Rome and its Province who are up to date with the payment of F.I.M.I. - E.B.A.R. contributions.

### REQUIREMENTS:

1. Applicants must not be beneficiaries of other grants for the same purpose and year;
2. At least one of the candidate's parents must be:
  - Owners of farms in Rome and its Province who are up to date with the payment of F.I.M.I. - E.B.A.R. contributions.
  - Agricultural workers employed on temporary contracts (OTD) must have been registered for at least 51 working days in the year prior to the application, and employers must be up to date with their F.I.M.I.- E.B.A.R. contributions for Rome and its Province.
  - owner of a farm up to date with F.I.M.I. - E.B.A.R. contributions of Rome and its Province.
3. All benefits and contributions will only be granted to companies, and their employees, up to date with their contributions to the FIMI - EBAR of Rome and its Province.
4. VAT will not be refunded under any circumstances.

If the number of applications submitted by the deadline exceeds the amount approved annually (Euro Ten Thousand/00 - €10,000.00), the Management Committee of F.I.M.I.- E.B.A.R. of Rome and its Province, at its sole discretion, will draw up a ranking list based on the following criteria:

1. Family income of everyone in the household (ISEE certification);
2. Family load as per tax certification
3. Date of arrival of the application.

### REQUIRED DOCUMENTATION:

Workers or farm owners wishing to apply for the subsidy for the purchase of school books must submit:

- 1) Application form, using the template provided, downloadable at [www.fimiroma.it](http://www.fimiroma.it) which must be filled in completely (front and back);
- 2) Certificate of family status on plain paper;
- 3) Certificate of enrolment or attendance for the current school year;
- 4) Copy of invoice or receipt certifying the purchase of the texts;
- 5) Certificate of registration in the population register or declaration by the employer or copy of the quarterly INPS reports showing the existence of the employment relationship;

- 6) Copy of previous year's income certification (signed CU or mod. 730 or mod. UNICO, INCOME FORM) of ALL THE MEMBERS OF THE FAMILY STATUS or, in the absence of income, the substitute declaration for affidavit certifying the absence of income;
- 7) In case of an orphan of a worker, in addition to the above documents, the death certificate of the deceased worker will also be required and the application may be signed by the parent;
- 8) Applicant's identity document.

### **DEADLINES FOR ACCEPTING APPLICATIONS:**

- Applications, accompanied by all documentation, must reach the F.I.M.I.- E.B.A.R. of Rome and its Province no later than **31 DECEMBER** of the current year.
- Applications will be examined by the Management Committee and will be granted at its sole discretion.
- Applications that are incomplete, lacking in documentation or received after the deadline will not be considered
